- 12. The licensee shall comply with applicable provisions of 0400-20-04, 0400-20-05, and 0400-20-10 of "State Regulations for Protection Against Radiation (SRPAR)."
- 13. Radioactive material authorized by this license may be stored at the Energy Solutions, LLC, Portal 10 rail track, Powerhouse Access Road, Oak Ridge, TN 37830.
- 14. A. Radioactive material authorized by this license shall be used by, or under the supervision of, Brian Cooley.
 - B. The Radiation Safety Officer for this license is Aaron Nance.
- 15. Licensed operations shall be conducted in accordance with applicable provisions of the Energy Solutions Tennessee Radiation Safety Guide (RSG-1), Revision 12.

SUPPLEMENTARY SHEET

16. An exemption is granted to the requirements in 0400-20-05-.115(3) of "State Regulations for Protection Against Radiation" that a package received during normal working hours shall be monitored within 3 hours, and that a package not received during normal working hours shall be monitored no later than 3 hours after the beginning of the next working day. Instead, the licensee may monitor a package received during normal working hours within the shift that it is received, or for a package not received during normal working hours may monitor that package within the first shift of the next working day. This authorization does not relieve the licensee from monitoring packages as soon as practical after receipt.

This exemption may be withdrawn or modified by the Department at any time it is determined necessary to protect the public health and safety or if it is found that the conditions on which this exemption is based have been violated.

- 17. No provision of this license relieves the licensee from compliance with other Federal, State, and local laws, ordinances, and regulations applicable to the licensee's activities.
- 18. Except as specifically provided otherwise by this license, the licensee shall possess and use radioactive material described in Items 6, 8, and 9 of this license in accordance with statements, representations, and procedures contained in the following:
 - Application dated November 1, 2016, with attachments
 - Letters dated November 1, 2016, November 14, 2017, with attached EnergySolutions
 Tennessee Radiation Safety Guide (RSG-1), Revision 11, December 5, 2017, June 11,
